## **Exam Guidelines:**

- All exams must be taken by Friday, June 5<sup>th</sup>, 2015.
  All courses will take final exams from May 28<sup>th</sup>-June 5<sup>th</sup>.
- Students arriving after 7:20 am will have to take their exam on the makeup day.
- Students may not be checked out before the exam window has closed on any given day.
- Students may leave school AFTER the exam window if they have submitted their early dismissal form.
- Once students leave campus after their exam, they may not return without a parent/guardian.
- Students should not be on other school campuses during exam days.
- Buses will depart at 2:18 pm each day. Students remaining on campus must be under the supervision of a staff member. Optional independent study halls will be available for students.

# **Senior Exam Exemption:**

If the senior student qualifies as exempt, according to the guidelines listed below, he/she will not need to attend the exam session.

# **Attendance Requirements for Exam Exemption** Seniors with:

- 3 or fewer absences with an A average
- 2 or fewer absences with a B average
- 1 or fewer absences with a C average

will not be required to take the final exam in that class unless the final exam is a state-mandated EOC exam or VOCAT exam.

A College Visitation Day is excused when the senior provides the prior approval form 1710 and proper documentation of the visit period. However, the day(s) absent for a college visit are still recorded as absences and count toward exam exemptions for seniors.
