## Sanderson High School PSAT Registration 2017

Test date: Wednesday, October 11, 2017 at 7:25 a.m.

The PSAT/NMSQT (Preliminary SAT/National Merit Scholarship Qualifying Test) will be administered at Sanderson High School on Wednesday, October 11, at 7:25 a.m. Registration is open August 31 through September 21.

The PSAT is a standardized, multiple-choice test that includes three sections: critical reading, mathematics, and writing. The test provides practice for the SAT. Students who take the PSAT/NMSQT are automatically screened for the National Merit<sup>®</sup> Scholarship Program, an academic competition for recognition and scholarships.

WCPSS will offer the test free of charge to SHS juniors who have a GPA of 4.2667 or higher. These students will be contacted directly during the first week of school. All other students will pay a \$16 fee to take the exam.

WCPSS students can pay through Online School Payment\* or in Student Services with exact cash or a check (before or after school, during lunch). Fee waivers are available for students based on financial need. All students testing must complete the form below and submit it, along with payment or receipt of payment, to Students Services.

\*Payment can be made by clicking the "ONLINE PAYMENTS" tab on the SHS website and selecting PSAT Registration. Please print and attach your receipt to this completed registration form and submit to Student Services.

(The PreACT will be administered free of charge to all WCPSS sophomores during the school day in October.)
