d. Operational Efficiency


Assignments will optimize the use of school facilities and transportation resources. Factors for consideration include:


Community feedback site generated 134 **parent comments** from the eight schools being considered for a calendar change

 - All impacted students will be eligible to request a transfer to grandfather at their current school (without transportation) for 2018-19
 - All impacted students will be eligible to apply to their new calendar option school (with transportation)
