		Students and parents understand that devices cannot be used at school for personal texting including parents texting their child.
		Students and parents understand that intentionally infecting the network with a virus, or program designed to damage, alter, destroy, or provide access to unauthorized data or information will result in disciplinary action.
		Due to infrastructure, students understand that printing from personal devices will not be possible at school.

		Students are expected to follow the Student Code of Conduct Board policy 6410, as well as Board policy 6446: Student Acceptable Use of Electronic Resources. Any violation may result in the loss of technology privileges at school, as well as other disciplinary action.
		The school has the right to collect and examine any device at any time.

Terms of the Responsible Use of BYOD Agreement

Bring Your Own Device is an optional program offered at our school allowing students to bring mobile technology devices to school for educational use. By bringing in a device from home, students help lower the ratio of students per device that our school's technology capacity allows for. This program is optional, not mandatory and it is a privilege, not a right. Mobile Technology devices include laptops, cell phones, iPods, iPads, tablets, Kindles, Chromebooks.

Parents/legal guardians and students must first sign off on the *Responsible Use of BYOD Agreement Form* prior to being allowed to bring any devices on campus.

1. Students take full responsibility for their devices.
2. Personal technology should not be left on campus before or after school hours.
3. Students must immediately comply with teachers' requests to shut down devices or close the screen.
4. Devices will not be used during assessments, unless otherwise directed by the teacher.
5. Devices will not be used with a substitute teacher in a classroom.

14. Students are expected to follow the Student Code of Conduct Board policy 6410, as well as Board policy 6446: Student Acceptable Use of Electronic Resources. Any violation may result in the loss of technology privileges at school, as well as other disciplinary action.

16. Devices must be logged in to the school network while on school property. Using personal data plans without school wifi is not permitted at any time.
