MISSION

The Wake County Public School System (WCPSS) Office of Grants & Strategic Advancement was established in 1985. Since its creation, the overarching mission has been to secure grant funding which helps advance the district's strategic goals and initiatives. In support, the office identifies grant funding opportunities and communicates this information to central office and school-based personnel. In addition, the Office of Grants assists staff with preparing applications and monitors implementation of grant awards.

VISION

Our vision for the day-to-day operations of the Office of Grants is to align all activities in support of the Wake County Board of Education's Mission adopted January 20, 2015, "Wake County Public School System will provide a relevant and engaging education and will graduate students who are collaborative, creative, effective communicators and critical thinkers." Per this mission, we proactively seek to identify funding opportunities which can provide support to programs or activities which promote the five strategic objectives for the Vision 2020 Strategic Plan: Learning & Teaching, Achievement, Balanced Assessment, Human Capital, and Community Engagement. In support, office staff practice positive consumer relations and seek to provide a same-day response to inquiries. Office staff also practice continuous improvement and seek to implement efficient and effective means of providing service to the WCPSS community; including administrators, teachers, and external agencies or organizations.

RESPONSIBILITIES

A principle responsibility of the Office of Grants & Strategic Advancement is to secure public and private funding through entitlement, competitive, and collaborative grants in ways that are consistent with school district priorities, applicable regulations, and relevant research findings. This responsibility includes the following functions:

- identify grant funding opportunities and communicate these to WCPSS personnel;
- advise the Wake County Board of Education of grant funding opportunities and seek approval for WCPSS staff to submit or collaborate on applications;
- assist district personnel with preparing and submitting grant applications;
- conduct training for WCPSS staff on identifying and applying for grants;
- interpret federal, state, and local rules and procedures governing grants;
- monitor grant programs for compliance with program and statutory regulations and ensure compliance with federal and state data reporting requirements; and
- collaborate with appropriate WCPSS departments including Academics, Human Resources, Special Education, and Student Support Services to ensure that grant program data are collected, compiled, and reported in an accurate and timely manner to comply with federal and state reporting requirements.

PURPOSE OF ANNUAL REPORT

Each year, the Office of Grants & Strategic Advancement prepares a summary of grant development activities for the prior year. This report describes major accomplishments, along with district-wide grant activity for the 2014-15 school/fiscal year. The report details the number and variety of grant applications submitted to various funding sources by Central Service personnel, school-based staff, and others on behalf or in support of WCPSS. This report is an account of the efforts across WCPSS to prepare and submit grant applications, as well as the subsequent success with securing grant awards. The report is not a financial accounting of grants managed by WCPSS. The dollar amounts noted for grant applications and awards are based upon figures reported to the Office of Grants & Strategic Advancement by departments, school staff, and external agencies submitting applications.

THE YEAR IN BRIEF

In 2014-15, the Office of Grants continued to help manage grants and compliance reporting activity. A bulleted list of activities and accomplishments for 2014-15 is included in the State of the Office Report as provided below.

ACTIVITIES AND ACCOMPLISHMENTS: 2014-15

Administration

- Presented to six schools on *Identifying and Applying for Grants* and during the fall 2014 Convergence Conference.
- Offered two sessions of grants proposal development for Central Office staff.
- Secured Board approval for 205 individual grant opportunities and 915 subsequent competitive applications (includes WCPSS and collaborative submissions).
- Updated the Office of Grants intranet web site after Board meetings.
- Assisted school-based and Central Service personnel with grant related requirements (e.g., grant agreements, annual reports, monitoring visits, and compliance).
- Completed annual update of Compliance Reporting Activity list.
- Participated in Annual Non-Public Schools Meeting.

Pre- and Post-Award

- Collaborated with external constituents (e.g., Marbles Kids Museum, NC Department of Public Instruction, NC State University, Town of Fuquay-Varina, Wake Education Partnership, Wake PTA Council, YMCA, and community-based organizations) on 33 grant proposals (e.g., Bill & Melinda Gates Foundation, Burroughs Wellcome Fund, Institute of Education Sciences, Institute of Museum and Library Sciences, John Rex Endowment, Kennedy Center for the Performing Arts, National Science Foundation, NC Quest, Triangle Community Foundation and others) and implementation for funded projects.
- Collaborated with Magnet & Curriculum Enhancement Programs to finalize award for Magnet School Assistance Program grant submitted in 2012-13 totaling \$10,335,043.
- Collaborated with K-12 Literacy, the Office of Early Learning, and six community agencies on a Changing Generations United Way of the Great Triangle Grant totaling \$134,737 to support the efforts of WAKE Up and Read.
- Collaborated NC State University, Middle School Programs, and the Wake Young Women's Leadership Academy on a Burroughs Wellcome Grant totaling \$177,428.
- Collaborated with NC State University and High School Programs Mathematics on a NC Quest Grant totaling \$135,085.
- Collaborated with WakeEd Partnership and Marbles Kids Museum to submit grants on behalf of WAKE Up and Read.
- Supported implementation and monitoring of grant-funded projects, including: Burroughs Wellcome Student Science Enrichment Program Grant, Elementary & Secondary School Counseling Grant, Magnet Schools Assistance Program, Javits Gifts and Talented Grant with Duke University, National Science Foundation Math Science Partnership Grant with NC State University, Museums Connect Grant with the NC Museum of Natural Sciences, Race to the Top, Teacher Incentive Fund, and Wake County Smart Start.

Professional Development

- Participated in webinars and conference calls with the United States Department of Education on 2014-15 Federal grants and shared the information with the WCPSS Superintendent's Leadership Team.
- Participated in 2014-15 webinars with the Campaign for Grade-Level Reading.
- Participated in NCDPI After School Quality Improvement Grant webinar.
- Attended sessions led by Instructional Technology staff on utilizing Google tools.
- Participated in Influencer, Facilitative Leadership, Leading Effective Meetings, and trainings offered through the Office of Professional Learning.
- Attended professional development sessions on Effective Research Design and Excel.
- Attended Academics Support Staff monthly meetings to learn about team building, précis development, and Crossroads emergency management updates.
- Attended Google app training with the Data & Accountability department.

Ad Hoc

- Participated in leading development of WCPSS Strategic Plan, Vision 2020, including: organizing Town Hall, collaborating with NC State University Friday Institute, facilitating twice monthly Strategic Plan Working Team meetings, and planning IBM Project Management training sessions.
- Participated in Student Assignment Transfer Appeal Hearings, facilitating table groups during East Wake Working Group sessions, and supporting annual Scholastic Pursuit event.
- Coordinated the 2nd annual WAKE Up and Read book drive, raising 115,000 books distributed to nine WCPSS schools and 20 Wake County childcare centers.
