



## PSAT Registration Form

**REGISTRATION DATES:** August 24 – **September 20, 2017**

**PSAT DATE:** **Wednesday, October 11, 2017**

***\* Identified Juniors do not have to complete this registration form—see criteria under “Who.”\****

**WHAT:** The PSAT is a standardized, multiple-choice test that includes three sections: critical reading, mathematics, and writing. The test provides practice for the SAT and offers insight for advising and counseling students.

**WHO:** The PSAT allows 11<sup>th</sup> grades students the opportunity to potentially qualify for a National Merit scholarship if they receive a very high score (generally the top 1%). For this reason, WCPSS is offering the test free of charge to those students with a **4.5625** GPA or higher. Panther Creek juniors who meet the criteria will be contacted by Student Services prior to September 2. All other students may take the PSAT/NMSQT for a fee of \$15.

***Other interested Panther Creek students who do not meet the criteria above should complete this form with payment to Student Services by **Wednesday, September 20**.*** Students who have not completed Math 1 (Algebra 1) should not register for the PSAT. A limited number of fee waivers are also available for students based on financial need.

**HOW DO STUDENTS REGISTER:** Submit the registration form and payment or proof of payment to Student Services by **Wednesday, September 20**. Juniors with a **4.5625 GPA** or higher will automatically be registered by PCHS. **Online payment or cashier's check made payable to Panther Creek High School will be accepted. Personal checks will not be accepted.**
