

PARKING ON CAMPUS



Parking Tag



- All students who park a motor vehicle on the school campus must display the current hanging-tag permit.
- The tag must be hung from the inside rear-view mirror, facing the front of the vehicle.
- Students who fail to properly display the tag will be ticketed or have their tags revoked.
- Vehicles parked in the wrong space or in unauthorized areas will be towed or “booted” at the owner’s expense and the permit will be subject to revocation without refund.

Where Am I Allowed to Park?

- Vehicles must be parked in assigned spaces.
- Students remaining on campus for after school activities are to leave cars in their assigned spaces until exiting campus.
- The only places available for student parking are the student lots.

Where Am I Allowed to Park?

- If somebody is in your spot, go see the nearest administrator and they will direct you where to park.
- Students may not park, at the apartment complex on McCrimmon, on the road, driveway, in intersections, in visitor spaces, in reserved spaces, or in any other place including other school campuses.
- Vehicles should be parked front-end first.
- Backing into spaces is not permitted.

On-Campus Driving Expectations

- Vehicles must not travel in excess of **10 miles per hour**.
- Seat belts are required for driver and all passengers.
- Speeding and reckless driving are prohibited.
- Exiting from student lots in the afternoon will be held until buses leave campus.
- Radio volume must be reduced and inaudible.
- Citations will be issued as necessary.

On-Campus Driving Expectations

- Supervision is provided for parking lots; however, the school system is not responsible for damages to or theft from vehicles.
- Students are cautioned NOT to leave valuables in their vehicles. Parked vehicles should be left with windows closed and doors locked.
- **Student vehicles are subject to search and seizure per Wake County School Board Policy 6600.**

On-Campus Driving Expectations

- School Board Policy 6410 prohibits the possession and/or use of tobacco products on campus. Students may not possess tobacco products or smoke in cars at any time while on the school campus. Weapon and drug charges will result in automatic revocation.
- Attendance and tardy policy violations may result in revocation of parking privileges.
- Chronic tardiness to first block and/or third block may result in revocation of parking privileges.
- Loitering in the parking lot is prohibited.

On-Campus Driving Expectations

- Students should lock their cars and leave the parking lot immediately upon arriving at school.
- Students should take all materials/items needed for the school day and not use vehicles as lockers.
- Students need written permission from an administrator, the SRO, or the parking lot attendant to be in student lots during school hours, including class changes.
- At lunch, only students using their official off-campus passes are permitted in the parking areas.

On-Campus Driving Expectations

- Student drivers leaving for off-campus lunch are responsible for knowing if persons riding with them have a lunch pass.
- Any student who provides transportation for a student who does not have a lunch pass or school permission to be off campus may lose his/her parking privileges for a time to be determined by administration.
- Between 6:00 a.m. and 6:00 p.m., student drivers may not enter the campus via the visitor/staff parking area. (Includes during SMART Lunch)

On-Campus Driving Expectations

- When the lunch bell rings students will walk to their cars.
- Running is prohibited and will result in suspension or revocation of parking privileges.
- Drivers are responsible for knowing whether or not their passengers possess valid off campus lunch passes.
- Have passes ready in order to expedite traffic.
- Misbehavior off campus will lead to disciplinary action.

Expectations At Dismissal

- Running is prohibited. Parking passes will be taken.
- All buses must leave campus before all other vehicles are permitted to exit the campus.
- Students parking nearest the stadium must wait until the last bus reaches the school building before backing out of their spots.
- Exit the campus the same way you entered except for stadium side spaces.
- Be alert to traffic stoppages from administration and or security.
- Be cautious when exiting campus.
- In the event of an accident, report it immediately to administration or the SRO.

OFF-CAMPUS LUNCH



Off-Campus Lunch Expectations

- In order to leave campus at lunch, an eligible student must present a PC lunch pass to the school official/security officer checking passes in the student parking lot.
- Using an off-campus lunch privileges to leave from the faculty/visitor parking lot an eligible student must exit through the main entrance and present a PC lunch pass to the school official checking passes.
- Students should also have in their possession a valid photo ID (driver license or Panther Creek ID) and should be able to present the photo ID upon request by school or security officials.



Off-Campus Lunch Expectations

- Not having the official lunch pass to show the school official/security officer prohibits a student from leaving campus.
- Any violations regarding departure from campus during lunch may result in revocation of the student's lunch pass.
- Any disciplinary matter may result in the revocation of the lunch pass privilege.
- Behavior off campus during the lunch period should be in compliance with system and school expectations and policies; infractions off campus may result in school disciplinary actions.

Off-Campus Lunch Expectations

- Any student who provides transportation for a student who does not have a lunch pass may lose his/her lunch pass and any parking privileges for a time determined by administration.
- Failure to return to class after the lunch period may result in the revocation of the lunch pass privilege.
- To leave school early and not return to class after being off campus for lunch, a student must officially sign out at the attendance office and must have parental permission through the attendance office.

Reminder: Student drivers are not allowed to enter the staff parking lot at the front of the school at anytime, including lunch.

Off-Campus Lunch Expectations

- Students with lunch passes may return to campus early but must abide by established school lunch rules, **including not remaining in the student parking areas or other off-limit areas.**
- Students are prohibit from going on other school campuses during the school day.
- Food purchased off campus is not permitted in the cafeteria/commons area.

Lunch passes are the property of Panther Creek High School and can be revoked at any time the passes are used improperly.
