## **ADHS School Improvement Plan Meeting**

## February 22, 2016

**Present:** Mr. Shaffer, Ms. Cleveland, Ms. Ruthven, Mr. Harrington, Ms. Childrey, Ms. Pexton, Ms. Price (parent), Ms. Childers (parent), Ms. Evanoff (parent), Ms. Davis (NC State student)

## **Vision/Value Statements:**

- Mr. Shaffer reviewed the proposed Vision Statement:
  - Athens Drive will facilitate meaningful relationships that ignite student's ability to become knowledgeable and productive members of the community, while eliminating socioeconomic status as a predictor of performance.
- All SIP team members agreed that it was a very strong vision statement, a
  parent raised the question that by including a statement about
  "socioeconomic status as a predictor of performance"-parents may
  conclude that this issue is currently a problem at ADHS. Ms. Cleveland
  explained the issue is one faced nationally by schools, known as the
  achievement gap, it is also a sentiment stated directly in the WCPSS
  Strategic Plan (#2)
- All SIP team members voted to accept the proposed Vision Statement which will be presented to the entire faculty/staff for a final vote
- Mr. Shaffer reviewed the proposed Value Statements:
- 1. Athens Drive will challenge every student with an effective and well supported staff to ensure success for all students.
  - Unanimous vote to accept
- 2. Athens Drive will provide meaningful21st century skills and experiences to prepare our students for active participation in the broader community.
  - Unanimous vote to accept
- 3. Athens Drive will promote effective communication among students, teachers, parents, and community stakeholders.
  - Unanimous vote to accept

- 4. Athens Drive will develop inclusive classrooms reflective of the diversity of our student and staff population.
  - A SIP team member expressed concern that the word "inclusive" denoted Special Programs students, Ms. Cleveland explained that as educator's we make that association but for non-educators the word generally implies "acceptance and tolerance"
  - Unanimous vote to accept
- 5. Athens Drive students will utilize global thinking skills in an engaging, collaborative learning environment to explore STEM and Medical Sciences.
  - A parent raised a concern about the STEM and Medical Science terms being included in the value statement wondering if the specificity would be a turn off to students who are neither STEM nor Health Science Academy students. Ms. Cleveland explained that every student at ADHS will feel the effects of the global/medical science magnet status as electives roll out and the magnet theme is integrated into each of the core classes
  - There was a proposal to take the wording out, the SIP team agreed however to alter the wording to include further clarification:
  - Athens Drive students will utilize global thinking skills in an engaging, collaborative learning environment and be provided the opportunity to explore STEM and Medical Sciences.

## **Data/Trend Statements:**

- Mr. Shaffer and Ms. Cleveland reviewed the importance of acquiring strong data to drive a successful School Improvement Plan
- The SIP team learned how to compose effective data statements to communicate a single idea about student performance including a data source, specific student subgroup, direction of the trend as well as a measurable amount over a set period of time
- Next the SIP team members split into small groups and assessed testing, demographic and discipline data to compose data/trend statements to be present as part of the Comprehensive Needs Assessment
