STUDENT COURSE SELECTIONS

The Wake County Public School System's high school program provides students many options based on their career goals, needs, and individual interests. Students may choose from a wide array of courses and programs. Choices students make in high school impact the options they have for future education and job opportunities after high school.

Students may select courses from Arts Education, Career and Technical Education, English Language Arts, World Languages, Healthful Living, Mathematics, Science and Social Studies.

Students must meet all course, credit, and test requirements of Future Ready Core to earn a high school diploma. The courses are designed to prepare students for postsecondary opportunities from entry-level career options to highly technical fields, from community colleges to colleges and universities. Students are encouraged to pursue the most challenging pathway in which they can be successful.

This planning guide is provided to assist students and their parents or court appointed custodians in the planning and registration process. It is the responsibility of all students and their parents or court appointed custodians to make sure that students are registered for the courses they need in order to meet graduation and college/university admission requirements.

Students will register for 2018—2019 courses <u>March 7– March 28.</u> The Dean of Students will create the schedule for the current 9th, 10th, and 11th grade students to follow for registering for classes.

Counselors will be available to assist students with entering course selections in Homebase/Powerschool. Students will receive a copy of their 2018– 19 course selections before leaving the registration site. Students should share this information with parents. Course selections can be viewed on Powerschool.

COURSE WITHDRAWAL PENALTY the overall GPA 2018—2019 SCHEDULE PICK-UP

All students will have an opportunity to pick-up class schedules before the first day of school. Class schedules will be distributed at Open House. Details on Open House will be sent to you during the summer. If you move or your mailing address changes, it is your obligation to contact the school with updated information.

New Student Orientation will be held in July. Students will have an opportunity to decide on courses for the upcoming school year.

SCHEDULE CHANGES

This spring, a series of scheduling activities will take place to assist each student in selecting the most appropriate courses for the 2018-2019 school year. Extensive time will be spent developing a master schedule that provides the best educational opportunities for our students. Schedule changes have serious effects on staffing, class sizes, and academic programs and will only be made under certain conditions. The following is a list of these conditions:

- Incomplete schedules (missing a class)
- Failure of a prerequisite course or incorrect course (English II
- Completion of course during summer school
- Master schedule conflict (two courses in the same period in the

The following reasons are NOT considered appropriate reasons for schedule changes and will not be honored:

- Dropping or adding a course because you changed your mind
- Block (class period) preference

A student who has met all graduation requirements and do not require a full schedule may seek to be released after serving at least half of the day. Students leaving before serving at least half of the day will be counted as a visiting student and will marked absent daily. Students will need to do the following to be considered for mid-day release:

- Present a written request from parent/guardian by May 18, 2018
- Conference to take place with counselor, student and parent to chart best course of action for student
- If a student is indeed eligible for mid-day release, they must have a reliable and consistent transportation everyday and exit campus immediately after their last class.
- If a student needs to remain after school for enrichment, events, etc, they must speak with administration 24-hours in advance so student supervision can be planned.

Students are not allowed to drop a course after the first ten days of school. If a student withdraws after the ten-day period and an emergency situation does not exist, a failure (WF) is noted as the grade, and the course is counted as a course attempted with no quality points earned. This will appear on the transcript and will be calculated into

- ☑ Select courses based on the list of offerings at Phillips. Course descriptions of course offerings can be found in the MEPHS Program Planning Guide.
- ☑ Consult with school counselors and other school personnel for assistance and answers to questions.
- ☑ Complete your Graduation Plan located on the next page of this guide.
- Record your course selections on the WCPSS High School Registration Work Plan form and transfer to the online registration program in Powerschool. <u>Make sure you select 8 courses and 3 alternates.</u>
- ☑ Have your parents double check your selections to make sure you have registered for the courses you need in order to meet graduation and college/university requirements.
- ☑ Print your course selections and ask your parents to review.

ENTERING COURSE SELECTIONS IN HOMEBASE/POWERSCHOOL

- Go to https://wcpss.powerschool.com/public/ in URL space. The HOMEBASE/POWERSCHOOL icon may be on your desktop.
- Enter your **POWERSCHOOL** User Name and Password.
- Click on "Class Registration" located in the left margin.
- To register for your classes click on the "pencil" icon next to each subject/category. Please select 8 classes and 3 alternates.
- Once you have selected 8 courses AND have 3 alternates click on <u>"SUBMIT</u> at the bottom of the page. NOTE: IF
 YOU DO NOT CLICK SUBMIT, THE COURSES YOU SELECTED WILL NOT BE SAVED!
- Print two copies of your course selections. Give one to Mrs. Pettis. Keep one for your records and share with your parents.
- Remember, you must select <u>8</u> primary courses and <u>3</u> alternates.
