 - Eligible Juniors and Seniors can request a Spring 2021 Off-Campus Lunch Pass at no cost.
 - Off-Campus lunch passes will go into effect on Monday, January 25, 2021. Prior to 1/25/2020, no students are permitted to leave campus during lunch.

Process to Receive an Off-Campus Lunch Pass:

- 1. Parents and eligible students fully complete this request form by filling in the items below.
- 2. Students **must** submit this application to **Student Services** on one of the following dates assigned by last name alpha.

- 4. If students are issued a temporary off-campus lunch pass, the temporary off-campus lunch pass will be exchanged for a permanent off-campus lunch pass as soon as their school photo becomes available.
- 5. Students must present their temporary pass to receive a permanent pass.

Parent/Guardian Agreement:
