Students will be held accountable for the information contained in this bulletin as well as the Code of Student Conduct for the Wake County Public School System. Summer school students are responsible for reviewing School Board Regulations 4309 Student Behavior, 4310 Honor Code and 3225/4312/7320 Technology Responsible Use.

Site Information and Important Dates

WCPSS Summer Session Dates: July 7- August 5, 2020 NC Virtual (formerly NCVPS) coursework will begin on June 17, 2020.

The school building will be closed. The entire summer program will be virtual.

2020 Summer School Eligibility and Academic Information

Population Served: Students enrolled at Crossroads FLEX for the 2020-2021 school year and Seniors needing to graduate in the 2019-2020 school year.

Students are admitted in the following priority order:

- Seniors (completing 4th year in Spring 2020) needing to graduate
- Juniors needing to be promoted and/or to support on ime graduation in Spring 2021
- Sophomores needing a class to be promoted
- Freshmen needing a class to be promoted
- To reduce courseload during the student's most demanding pursuit season (documentation **must** be provided, i.e. travel schedule, performance schedule. If pursuit schedules are not currently available due to COVID-19, the student may submit schedules from the previous year.)

Crossroads FLEX will use the GradPoint curriculum placement assessments and NC Virtual platform with recommended supplemental materials. At this time, due to COVID-19, End-of-Course (EOC) tests may not be given to students enrolled in an EOC class according to guidelines set by the North Carolina Department of Public Instruction and the WCPSS Testing Office.

There is no charge to students for 2020 Summer School courses, however the district does incur a cost for each student that enrolls in a course. As a result, students need to be committed to completing the course in its entirety during the summer school program.

Grade Reports:

- 1. Notification of summer school grade is mailed to students at the end of the Summer School session in place of an official report card. Parents need to monitor progress on a daily basis via NC Virtual Observer view.
- 2. Due to COVID-19, exams *may* not be administered to students at the end of the session. End-of-Course tests are typically administered in Math I, Math III, Biology, and, English II on August 4th and 5th.
- 3. The grade earned in GradPoint Credit Recovery Summer School will **not** count toward the GPA but will appear on the transcript. Students completing coursework on GradPoint will receive Pass or Fail. All previous grades remain on the transcript and are calculated in the GPA (note: PC-19 or WC-19 for the Spring 2020 semester does not calculate into GPA).
- 4. The grade earned for repeat credit or first time credit courses through NC Virtual will count toward the GPA and will appear on the transcript.

2020 Summer School Policies and Procedures

Laptop Device Expectations:

Returning students will use their current laptop to complete coursework. Students new to Crossroads FLEX must provide their own device to begin the course. If a student new to Crossroads FLEX needs a WCPSS laptop device, arrangements may be made to provide them one starting July 7th.

Virtual Class Meeting Expectations:

Beginning June 17, students will be required to complete at least one virtual meeting each week with the FLEX summer school teacher or coordinator through August 5. This will allow time for us to check in with students and their progress considering such a short time to complete an entire course. If the student is not showing consistent progress in the course, these weekly meetings will be increased and parent contact is made to communicate concerns.

Coursework Expectations:

Summer School coursework is assigned Monday through Friday virtually through the NC Virtual Canvas platform. Students should familiarize themselves with Canvas, and reach out to the teacher for any assistance. The pace of the summer school curriculum moves quickly; it is imperative that students implement productive time management strategies and <u>dedicate multiple hours each day to their coursework.</u> Students should create a schedule that will help to avoid assignments being submitted late.

Summer School Attendance Policy:

One day in summer school is equivalent to approximately two weeks of traditonal school. Thus, weekly check-in meetings with the FLEX summer school teacher are necessary and count toward the student's attendance. Failure to communicate with the summer school teacher and submit coursework on a consistent basis may increase a student's virtual face time with the CFLEX summer school teacher and could ultimately result in withdrawal from the course if improvements are not seen.

Conduct:

Misbehavior will not be tolerated within the virtual summer school environment. The consequences of misbehavior may result in removal from summer school and subsequent loss of credit.

All Wake County Public School System rules regularly enforced during the school year are the same for students who attend the 2020 summer school session. Please refer to the 2019-2020 WCPSS and CFHS Student/Parent Handbook for specific information. Students are reminded of some important policies and guidelines.

- 1. Loss of technology and/or damage to technology will incur a fine and the fine is expected to be paid before the start of the next school year.
- 2. Students at Crossroads FLEX and NC Virtual adhere to a strict Honor Code. Cheating and/or plagiarism are a violation of academic integrity and will not be tolerated. Consequences for integrity violations include parent contact, resubmission of assignments, and/or grading penalties. Repeated occurrences may result in withdrawal from the course.
- 3. Major infractions, as determined by the administrator, may result in removal from the Summer School program and/or suspension.
