

From the Principal....

Dear Parents,

I hope you and your family are safe and healthy. We have officially completed four weeks with students back in the building. Words cannot express how happy we are to have students back for inperson learning. They have lifted our spirits and brought joy to the building. You should be incredibly proud of your children...they have been amazing following the many protocols and procedures we have in place.

Registration for Virtual Academy/In-Person Spring Semester

The registration window for the WCPSS Virtual Academy for the spring semester of the 2020-21 school year is **Dec.** 2^{nd} – **Dec.** 9th.

This registration window will allow:

- Currently enrolled WCPSS Virtual Academy students the opportunity to return to in-person instruction during the spring semester;
- WCPSS Virtual Academy students registered for fall only to continue in the WCPSS Virtual Academy for the spring semester; and
- Students who are not currently registered for the WCPSS Virtual Academy the opportunity to register for the spring semester.

Students who are registered in the WCPSS Virtual Academy for the entire year and who wish to remain registered for the spring semester do not need to take any action.

Students who are not currently registered for the WCPSS Virtual Academy and who do not wish to register for the spring semester also do not need to take any action.

It is important to understand that teachers are currently assigned to In-person, Virtual Academy (Fall Only), or Virtual Academy (Full Year) classes. Depending on the number of students who switch learning environments for the second semester, I may have to assign students to a different class/teacher. I may also have to assign teachers to a different learning environment (VA or In-person). As I plan for the second semester, my primary goal is to minimize the number of students who need to switch teachers. Parents will be notified as soon as these decisions have been made.



Changes in Social Distancing Expectations

On Monday, November 16th, all K-3 and regional program students returned to school with all their classmates (full class). Fortunately, our current K-3 in-person class sizes are small enough that we can continue to maintain 6 ft. social distancing in these classrooms.

Beginning Jan 20th, 4th & 5th grade in-person classes return with all students (full class). Given the larger size of our 4th & 5th grade in-person classes, we will not be able to maintain 6 ft. of social distancing in these classrooms. We will continue to social distance whenever possible, but 4th & 5th classrooms are not expected to maintain six feet of space between desks or students if space does not allow. Additionally, depending on the number of students who switch to in-person learning for the second semester, our K-3 class sizes may increase to a size where we are unable to maintain 6 ft. of social distancing.

Did a student go home sick? Please remember, all household members must also go home.

Effective immediately, if a WCPSS student or employee does not pass the health screening or if they stay home or are sent home because they are experiencing a symptom of illness, their household members must also stay home. This means that any WCPSS student or employee living in the same house must quarantine for 14 days. The household members may return sooner than 14 days if the person experiencing a symptom of illness receives confirmation of an alternate diagnosis or a negative PCR/Molecular test.
