\*Only students who missed one of their exams, and need to complete a make-up exam, or need to take Math 1 or English 2 if they took them in the same semester should attend school on this day.

**Exam Scoring** - All exams will count as 20% of the student's final grade. Exam scores will be averaged into the final grade and will impact the final course average either positively or negatively depending on the student's grade.

### **Senior Exam Exemption Requirements:**

Seniors can only be exempt from their exam for any course that does not require state testing (EOC/CTE state exam) and for which the student has a final average of 80% or higher, must have no more than 10 total absences (includes excused, unexcused, & college visitations).

*Note: Does not apply to AP Courses from the AP College Board. Teachers may exempt any AP teacher made exam.*

## Exam Guidelines:

- From Thursday, June 6, through Wednesday, June 12, students must remain in the classrooms for the duration of the exam block. **In order to maintain the integrity of all assessments and provide optimum opportunity for success for all students, students will NOT BE ALLOWED to check out early during exam blocks. Please schedule appointments, etc. accordingly.**
- Students are expected to take exams at the scheduled times. Students must be present at the beginning of each exam period to take the exam and must remain in the exam period room to receive credit for the exam.
- Students who remain on campus after EOC or make-up exams conclude must remain in the designated supervised areas and follow the schedule provided on those days.
- According to North Carolina testing policy, students are not allowed to bring electronic devices (other than approved calculators) into the testing room at any time during state testing, including breaks. Any student with a cell phone/electronic device during the testing period must be dismissed from testing, and a misadministration will be declared for that student. A student who has been dismissed for a violation of the electronic device policy must take the missed EOC exam on a make-up day. Per WCPSS Board Policy 3225, the student is subject to disciplinary action by the school administration.
- If absent from an exam, a student must submit a parent note to the Attendance Office upon return to school. The student is responsible for working with their teacher to schedule the make-up exam for a non-stated mandated exam. For a state exam (EOC or CTE post assessment), the testing coordinator for those exams will schedule the make-up exam.
- Under no circumstances can students be on other school campuses on exam days.
