**Sanderson High School PSAT Registration 2019**

**Test date: Wednesday, October 16, 2019 at 7:25a.**

The PSAT/NMSQT (Preliminary SAT/National Merit Scholarship Qualifying Test) will be administered at Sanderson High School on Wednesday, October 16, at 7:25a. Registration is open September 4 through September 13. **Registrations will not be accepted after 2:30p on September 13.** Registration is complete once payment has been made AND the form turned in to Student Services.

The PSAT is a standardized, multiple-choice test that includes three sections: critical reading, mathematics, and writing. The test provides practice for the SAT. Students who take the PSAT/NMSQT are automatically screened for the National Merit® Scholarship Program, an academic competition for recognition and scholarships.

WCPSS will offer the test free of charge to SHS juniors who have a GPA in the top 10% of the **district**. These students will be contacted directly during the week of September 9 and *must complete a registration form in order to participate*. All other students will pay a \$17 fee to take the exam.

WCPSS students can pay through Online School Payment\* or in Student Services (before or after school; during lunch) with exact cash or a check made out to Sanderson High School. Fee waivers are available for students based on financial need. All students testing must complete the form below and submit it, along with payment or receipt of payment, to Students Services.

\*Payment can be made by clicking the "ONLINE PAYMENTS" tab on the SHS website and selecting PSAT Registration. Please print and attach your receipt to this completed registration form and submit to Student Services.

*(Note: The Pre-ACT will be administered free of charge to all WCPSS sophomores during the school day in October)*
