



Through Career and College Promise (CCP), eligible high school students have the opportunity to take community college classes, tuition free, while they are in high school.

Students who meet the eligibility criteria, including an unweighted GPA of at least 2.8, can apply. In addition to the general eligibility requirements, 9th and 10th graders planning to begin the program prior to their junior year must meet the additional quidelines outlined here:

How does dual enrollment with CCP work?

- Students can receive high school credit for any course they complete that is worth at least 3 credit hours. The course will be reported on your transcript and will also factor into your GPA.
- There are two primary pathways through which students may take courses: the College Transfer (CT) Pathway and the Career and Technical Education (CTE) Pathway.
 - In receiving high school credit for these courses, courses that fall within the CT Pathway carry the same weighting as AP level course (i.e., one extra quality point).
 - Most courses that fall within the CTE Pathway carry the same weighting as an academic level course (i.e., no added quality points beyond the standard weighting).
 - □ Carefully review the pathways to be certain of what courses will be accessible to you and in which combination.
- CCP courses may either be online or in-person.
- In-person courses should not conflict with your AFHS classes in anyway, including commuting.
- Most CCP courses will count as elective credits, but there are a few courses that can satisfy core graduation requirements.
 - □ Please note, World Language courses are not eligible for dual enrollment credit.
- Students taking courses through CCP may request to have a reduced schedule of classes at AFHS. Students must be enrolled in at least two AFHS courses, and students are not permitted to be on AFHS's campus during periods they are not enrolled with us. For this reason, please be sure you can provide your own reliable transportation to or from campus.
 - □ We cannot guarantee student parking at AFHS even if you are participating in CCP.

When can students apply for CCP?

- Students participating in CCP through Wake Tech can apply during Wake Tech's application period, which typically occurs midsemester during the fall and spring semesters.
- Students will apply to participate in the program the semester prior to the term when they plan to begin.
- Rising seniors are even eligible to take courses during the summer term (underclass students must meet specific eligibility requirements for summer courses).

How can students apply for CCP?

 - ☐ First time applicants are strongly encouraged to watch the informational video first and carefully review the instructions for selecting the appropriate pathway.
- 9th and 10th grade students who plan to begin CCP prior to the start of their junior must follow the two previous steps AND provide the additional documentation enumerated in the document above. Before beginning the application process, 9th and 10th grade students must meet with Ms. Wilson in Student Services.
