The registration period for fall 2022 is open. The are 105 seats for fall classroom and students will be placed based on age. Spring registration dates will be posted later this semester. <u>www.jordandriving.com</u>

Between 9/7 and 9/9, I will notify the students who are placed in the first (October) session with a payment link and due date. I will move to November and then December once the October roster is finalized.

- 1. Students <u>must attend</u> the 30 hours of class and other commitments (practice, rehearsals, extra-curricular) are under no expectation to excuse for driver ed. ****Find out when winter dress rehearsals and concerts are NOW.****
- 2. There is one session per month beginning with October; all classroom sessions are face-to-face from 2:30-5:30 for 10 days. Students are placed in the session based on age, oldest to youngest. Students must be off campus by 5:45.
- 3. Do NOT make payment until you have received notice of placement in the class. You will receive a payment link once the session roster has been set.

Behind-the-Wheel (BTW): Please read.

- 140 students took the summer classes offered at FVHS across 4 sessions. The <u>June students</u> are with our drivers as of 9.1. Contact/Scheduling takes place on a rolling basis over the next 3-4 weeks. Remember our drivers may work full-time jobs.
- <u>The July class</u> will likely move to BTW in 6 weeks. Then we have the August sessions to schedule thereafter.
- Students are sent to a BTW instructor roster based on the class session they took and age within the class.
- BTW must be scheduled with the parent/guardian. Inform your students to share with you if they are called due to putting their number on their forms.
- Please speak to your driver via phone call if s/he texts you as initial contact. Drivers meet students at LRHS and must return students to LRHS for parent pick-up at the conclusion of the driving lesson.
- Please save the contact information for your driver so that you can get in touch with the driver if there is a need to follow up or for any BTW questions.
- Once BTW concludes, the driver will issue a Certificate of Completion. Please review it carefully BEFORE you leave the lesson. If you lose it, refer to this link to request a \$20.00 replacement copy from JDS: Lost Driver Education Certificate | Jordan Driving
- **DMV Eligibility Certificates** (DEC) are issued through the front office and can be picked up by the student or/parent. You will need to show your copy of the certificate of completion. You must have it for your DMV visit.
- Students must remain in good academic standing; DMV will issue a revocation as outlined below from page 14 DMV handbook:
 - DMV must revoke the driver license of any person under age 18 when it receives notice from the proper school authority that the person is no longer eligible for a Driving Eligibility

Certificate. This revocation remains in effect until the person's 18th birthday unless a Driving Eligibility Certificate, high school diploma or GED Certificate is obtained.

- Wear appropriate clothing and shoes for BTW no sandals, flip-flops, etc.
