Just a few reminders. Under [Policy Code: 3225/4312/7320 Technology Responsible Use](#), students may not have cell phones accessible during the instructional day. They will be asked to lock them in their lockers upon arrival. If a phone is seen, all students will be given one reminder to lock the phone in their locker. If it continues to be in the student’s possession the phone will be taken to the front office and secured. You will be asked to come to school and retrieve the phone. Phones have proven to be a distraction to instruction. If your child requires their phone on them for a documented medical condition or need, they will be permitted. This exception requires communication between the parent and administrative team. Please discuss this with your child prior to school starting.

The North Carolina state budget includes funding that allows Child Nutrition Services to provide free breakfast and lunch to all students who are eligible for reduced-price meals for the 2022-23 school year! Child Nutrition Services is making arrangements to credit the accounts of reduced-price eligible students who purchased meals at the reduced-price rate of 40 cents since the start of the 2022-23 school year.
