Exam Schedule Information:

- Students will take all teacher made, End of Course, and CTE Exams in person during their scheduled exam block. Students must remain in their classrooms for the duration of the exam block in order to maintain the integrity of all assessments and provide optimum opportunity for success for all students, **students will NOT be permitted to check out early during the exam block.**
- The exam block will end around 11:00 am each day and all students with a signed dismissal form may leave campus at that time. Students without a signed dismissal form will remain in the commons area for a study hall until the buses leave at 2:18 pm.
- Students who arrive late to school on the day of the exam will not be allowed to test. They will need to attend a make-up session on June 10th.
- A grab and go breakfast and lunch will be provided for all students on exam days.
- Exams will count as 20 percent of the student's final grade. Exam scores will be averaged into the final grade. The exam grade will impact the final course average either positively or negatively depending on the student's grades.
- For the 2021-2022 school year, students in Grade 12 only are eligible to be exempt from teacher made exams only based on a projected final course average of C or higher. Absences will not be considered in determining exemption status for the 2021-2022 school year. The principal has final authority to determine a student's exemption status.

Exam Early Release - Spring 2022

This year, WCPSS will NOT run buses in the middle of the day during exams. Therefore, a permission form is required from each high school student if he/she plans to leave **after** their designated exam block at 11:00 am. Parents who wish for their student to leave campus following the student's exam administration should complete this form and send it with the student on each day of testing. This will authorize the student's early release following his/her exam session. *Students will not be permitted to leave during the exam administration period, regardless of the time they finish testing.* If the student does not return this form, the student must remain in the commons area for a supervised "study hall" until school releases at 2:18 pm.

GENERAL INFORMATION

- Once testing has started, students will not be allowed to enter the test area. Any student late to their testing session will have to report to campus at 7:20 a.m. on Friday, June 10, 2022, to take a make-up exam.
- In order to maintain a secure testing environment, students will NOT be allowed to check out during an exam administration.
