OFFICE OF GRANTS & STRATEGIC ADVANCEMENT ANNUAL SUMMARY REPORT: 2016-17

MISSION

The Wake County Public School System (WCPSS) Office of Grants & Strategic Advancement was established in 1985. Since its creation, the overarching goal has been to secure grant funding which helps advance the district's mission and strategic goals or initiatives. In support, the office identifies grant funding opportunities and communicates this information to central office and school-based personnel. Also, the Office of Grants assists staff with preparing applications, monitors implementation of grant awards, and provide general oversight for district compliance activities.

VISION

The vision for the day-to-day operations of the Office of Grants is to align all activities in support of the Wake County Board of Education's Mission adopted January 20, 2015, "Wake County Public School System will provide a relevant and engaging education and will graduate students who are collaborative, creative, effective communicators and critical thinkers." Per this mission, the Office of Grants proactively seeks to identify funding opportunities which can provide support to programs or activities which promote the five strategic objectives for the Vision 2020 Strategic Plan: Learning & Teaching, Achievement, Balanced Assessment, Human Capital, and Community Engagement. In support, office staff practice positive consumer relations and seek to provide a same-day response to inquiries. Office staff also practice continuous improvement and seek to implement efficient and effective means of providing service to the WCPSS community; including administrators, teachers, and external agencies or organizations.

RESPONSIBILITIES

A primary responsibility of the Office of Grants & Strategic Advancement is to secure public and private funding through entitlement, competitive, and collaborative grants in ways that are consistent with school district priorities, applicable regulations, and relevant research findings. This responsibility includes the following functions:

- identify grant funding opportunities and communicate these to WCPSS personnel;
- advise the Wake County Board of Education of grant funding opportunities and seek approval for WCPSS staff to submit or collaborate on applications;
- assist district personnel with preparing and submitting grant applications;
- conduct training for WCPSS staff on identifying and applying for grants;
- interpret federal, state, and local rules and procedures governing grants;
- monitor grant programs for compliance with program and statutory regulations and ensure compliance with federal and state data reporting requirements;
- collaborate with appropriate WCPSS departments including Academics, Human Resources, Special Education, and Student Support Services to ensure that grant program data are collected, compiled, and reported in an accurate and timely manner to comply with federal and state reporting requirements; and
- provide general oversight to assist district departments to fulfill federal, state, and local compliance requirements.

PURPOSE OF ANNUAL REPORT

Each year, the Office of Grants & Strategic Advancement prepares a summary of grant development activities from the prior year. The timing of this report is dictated by award notifications from funding agencies, some of which can take up to a year for a review of applications.

This report describes major accomplishments, along with district-wide grant activity for the 2016-17 by Central Service personnel, school-based staff, and others in collaboration and the support of WCPSS. This report is an account of the efforts across WCPSS to prepare and submit grant applications, as well as the subsequent success with securing grant awards. The report is not a financial accounting of grants managed by WCPSS. The dollar amounts noted for grant applications and awards are based upon figures reported to the Office of Grants & Strategic Advancement by departments, school staff, and external agencies submitting applications.

THE YEAR IN BRIEF

In 2016-17, the Office of Grants continued to help manage grants and compliance reporting activity. A bulleted list of activities and accomplishments for 2016-17 is included in the State of the Office Report as provided below.

ACTIVITIES AND ACCOMPLISHMENTS: 2016-17

Administration

- Supported school efforts to submit grants by increasing awareness of WCPSS requirements and providing adult learning opportunities on *Identifying and Applying for Grants*.
- Secured Board approval for 258 individual grant opportunities and 876 subsequent competitive applications (includes WCPSS and collaborative submissions).
- Updated the Office of Grants intranet website after Board meetings to share opportunities.
- Assisted school-based and Central Service personnel with grant-related requirements (e.g., grant agreements, annual reports, invoicing, monitoring, compliance, and close-out).
- Completed annual update of Compliance Reporting Activity list.

Pre- and Post-Award

- Collaborated with external constituents (e.g., Carolina Ballet, Duke University, NC State University, University of NC at Chapel Hill, Wake PTA Council, YMCA, and communitybased organizations) on 52 grant proposals (e.g., 21st Century Community Learning Centers, Carolina Hurricanes Kids 'N Community Foundation, Institute of Education Sciences, Kennedy Center for the Performing Arts, National Institute of Justice, National Science Foundation, Spencer Foundation, UNC General Administration, US Department of Education GEAR Up Program, and others) and implementation of funded projects.
- Supported grants development, implementation, monitoring, and close-out of grant-funded projects, including: Burroughs Wellcome Student Science Enrichment Program Grant, Elementary & Secondary School Counseling Grant, Magnet Schools Assistance Program, Javits Gifts and Talented Grant with Duke University, National Science Foundation Math Science Partnership Grant with NC State University, Teacher Incentive Fund and Wallace Foundation Grant with NC State University.

Professional Development

- Participated in webinars and conference calls with the United States Department of Education on 2016-17 Federal grants and shared the information with district leadership.
- Participated in 2016-17 webinars with the Campaign for Grade-Level Reading, including Pacesetters and All-America City Contest opportunities.
- Participated in US Department of Education's 2017 MSAP Grant webinar series.
- Participated in regular departmental led professional learning.
- Attended Google Basics training and the Google Apps for Education Summit.
- Attended The Foundation Center's corporation and foundation proposal development training.
- Attended the WCPSS Office of Professional Learning training on the Dilemma Consultancy Protocol, as well as the Art & Science of Presenting.
- Attended the WCPSS Data, Research, & Accountability training on Analyzing & Reporting Data.
- Attended Academics Support Staff monthly meetings to learn about team building, précis development, and Crossroads emergency management updates.
- Attended training to support the WCPSS Strategic Plan, including #Wake Vision.

Ad Hoc

- Supported WCPSS Strategic Plan, Vision 2020, and implementation, including prioritized strategic objectives activities for grants development and led a Community Engagement subcommittee.
- Implemented the 4C Fund, including the selection of awardees, project implementation, and budget management.
- Prepared and submitted the award-winning 2016 Pacesetter's application for the National Campaign for Grade-Level Reading on behalf of WAKE Up and Read. The application was subsequently identified as a finalist for the All-America City Award.
- Participated in initial discussions with Carolina Hurricanes to plan for Readvolution.
- Participated in organizing 4th annual WAKE Up and Read book drive, raising over 110,000 books distributed to ten WCPSS schools, nine youth-serving community centers, and 20 Wake County childcare centers.
- Served as facilitators during the NC State University led education summit.
- Led monitoring of updates on the Every Student Succeeds Act (ESSA) legislation and Federal, as well as State efforts, to migrate from No Child Left Behind to ESSA.
- Served as a panelist on the NC State University Research Practitioner Summit.
- Provided professional development to the Wake Ed Partnership Beginning Teacher Leadership Network.
- Volunteered with the WCPSS Habitat Build effort.
