## Wake County Public School System APPEAL FOR ATHLETIC PARTICIPATION FOR TRANSFERRED STUDENTS

**Board Policy 6203H:** A student who is granted a voluntary transfer away from the base or assigned school shall not participate in athletic activities that come under the jurisdiction of the North Carolina High School Athletic Association (NCHSAA) and the State Board of Education for 365 days from the first approved transfer date. The Superintendent or his/her designee may review appeals of this section of Policy 6203 and may grant permission for students to participate in athletic activities based upon such hearings. The Superintendent shall require written regulation and procedures to govern appeals of this section of Policy 6203. Students entering ninth grade for the first time are eligible to participate in athletic activities and are not required to file an appeal. 6203 R & P, B1: To appeal policy 6203H, the Wake County Public School System Appeal for Athletic Participation must be completed and submitted to the Senior Administrator for Athletics as the Superintendent's designee.
