### Senior Exam Exemption Requirements:

Seniors cannot be exempt from a state exam (CTE, EOC and NCFE exams.) Seniors can only be exempt from a teacher-made exam. If the senior student qualifies as exempt, according to the guidelines listed below, he/she will not need to attend the exam session.

Seniors with:

- 3 or fewer absences with an A average
- 2 or fewer absences with a B average
- 1 or fewer absences with a C average

### Exam Guidelines:

- EOC, NCFE and CTE Post-assessment exams count for 20% of a student's semester grade.
- Students are expected to take exams at the scheduled times. Students must be present at the beginning of the exam period to take the exam and must remain for the entire exam period to receive credit for the exam.
- If absent from an exam, a student must submit a parent note to the Attendance Office upon return to school. The student is responsible for working with the teacher to schedule the make-up exam for a teacher-made exam. For a state exam (CTE post assessment, EOC or a NCFE), the assessment coordinator for those exams will schedule the make-up state exam.
- Students who do not have an EOC exam or a make-up exam do not report to school on January 23rd, 24th or 27th. Students who remain on campus after the EOC exam or make-up exams conclude must remain in the designated supervised areas and follow the schedule provided on those days.
- According to North Carolina testing policy, students are not allowed to bring electronic devices (other than approved calculators) into the testing room at anytime during state testing, including breaks. Any student with a cell phone/electronic device during the testing period must be dismissed from testing, and a misadministration will be declared for that student. A student who has been dismissed for a violation of the electronic device policy must take the missed EOC exam on a make-up day. Per WCPSS Board Policy 3225, the student is subject to disciplinary action the school administration.
- Under no circumstances can students be on other school campuses on exam days.
