## **Responsibilities of Student Council Members**

- 1) Membership of the Student Council shall consist of the Executive Board of Officers (President, Vice-President, Secretary, Treasurer, Parliamentarian, and Historian) and class officers and representatives (President, Vice-President, Secretary, Treasurer, and three representatives per class).
- 2) Members of Student Council are expected to attend all meetings of the Student Council. Members who have more than two unexcused absences per semester shall be subject to impeachment for failure to fulfill their duties. Prior approval is needed from the Student Council faculty adviser for excused absences. Meetings are held every Tuesday after school. Those involved in athletics or other extra-curricular activities after school need to speak to me directly before applying.
- 3) Members of Student Council are required to participate in activities planned by Student Council. Members who do not fulfill this requirement shall be subject to impeachment for failure to fulfill their duties.
- 4) All officers and members of the Student Council shall maintain a 2.0 weighted grade point average at minimum. Any officer or member whose grade point average falls below a 2.0 in any quarter shall be placed on probation until the next interim report. Students on academic probation are prohibited from voting in any Student Council decisions. If the member's grade point average remains below a 2.0 following the interim report, the student will be suspended from Student Council.
- 5) Each member and officer of Student Council must maintain a high standard of ethical and moral conduct. Any violation will result in automatic suspension from the Student Council. Violations include, but are not limited to, cheating on any assignment, after-school detention, and out-of-school suspension. Student Council Advisors and/or the AFHS Administration reserve the right to remove a Student Council member for any violation.
- 6) For those students seeking a position on the Executive Council or class president, please see additional expectations for you listed below in the section pertaining to those offices.
