Dance Guest Permission Form

Individuals Not Enrolled at Panther Creek High School - Homecoming 2018

A Panther Creek High School student's receipt of this form indicates his/her intention to bring a guest who is **not** enrolled at our school to our Homecoming Semi-Formal Dance on October 6, 2018. As a result, the Panther Creek student will assume responsibility as the "sponsor" of the guest. In addition, the Panther Creek student **must** submit this form with the required information at the time of his/her purchase of a ticket for the guest. The completion of this form and its subsequent submission at the time of ticket sales is the only way a Panther Creek High School student will be eligible to purchase/receive a ticket for a person not enrolled at our school. The Panther Creek student will not be permitted to purchase more than **one** guest ticket for the dance.

In addition to the requirement of completing and submitting this form to purchase/receive a guest ticket for a person not enrolled at our school, both the Panther Creek student and his/her guest must adhere to the requirements listed below on the night of the dance.

1. The guest and the Panther Creek High School student must identify themselves by presenting a picture ID to the staff members at the check-in table upon their arrival to the dance. **No individual, regardless of his/her status as a current Panther Creek High School student or guest, will be admitted without a photo ID.**
2. The guest and the Panther Creek student must enter the dance at the same time. **An individual who is not enrolled at our school will not be admitted to the dance alone. If the Panther Creek "sponsor" is not present with the date at the check-in table when the guest arrives, the guest will be denied admission and will be required to leave campus immediately. Admittance to the dance may be denied after 9:00 PM.**
3. Dance tickets at Panther Creek High School are NOT transferable or refundable, once purchased. Thus, every ticket presented at the check-in table on the night of the dance must match the school's ticket roster in terms of the ticket number and name of the ticket holder. **Any discrepancies will lead to all individuals associated with this issue being dismissed from the dance.**
4. **PCHS administration reserves the right to deny admission to any school function if student conduct merits such action. Students and guests must follow the policies as outlined in the WCPSS Student Code of Conduct, School Board Policy 6410. (Alcohol sensors may be used prior to a student or guest being admitted to the dance.)**
