2019-20 Advanced Placement Students and Parents,

Welcome to the 2019-20 school year. We are excited that you are enrolled in an Advanced Placement (AP) course. College Board, creators of Advanced Placement, has made significant changes to the AP exam ordering process, deadlines, late fees and cancellation fees that will be mandated for all schools and all students in the 2019-20 school year.

During the 2019-20 school year, all students enrolled in a Fall Semester AP course will decide whether or not to take the corresponding AP exam and will place their order online through their CollegeBoard account by the school's internal deadline of October 18, 2019. The internal ordering deadline for Spring Semester AP courses will be February 21, 2020.

Students should adhere to Panther Creek's internal deadline. All students in Fall Semester classes who cancel their AP test after November 15, 2019 will be assessed a \$40.00 per exam fee.

All 16 UNC colleges and universities will give credit to students who earn a score of "3" or higher on Advanced Placement exams, except in cases when a course has been granted an exception by an institution's Board of Trustees. North Carolina pays for each student who is enrolled in an AP course at the school to take that specific AP exam. As a result, the AP exam is free of charge to students and they are encouraged to take the AP exam for that course. If a student registers for an AP exam and/or cancels after November 15, 2019, the student is responsible for paying the \$40 cancellation fee and/or order fee.

CollegeBoard also provides students with support resources and materials that can be accessed throughout the AP courses they are enrolled in. This is a wonderful opportunity for students and more information will be provided by their teacher.

Please keep in mind that these changes are being implemented by College Board and not the school or district. Please complete the 2020 AP Consent Form and return it to your teacher.
