**Off-Campus Lunch Rules and Regulations 2019-2020**

Please note the following stipulations regarding lunch passes:

1. The off campus lunch pass is the property of Garner Magnet High School and may be revoked at any time in cases of inappropriate use or violation of school rules.
2. Excessive tardies and/or absences in the period following a student's lunch period may result in disciplinary action and/or revocation of the off campus lunch pass and/or parking permit.
3. The off campus lunch pass allows a Junior or Senior to leave campus during his/her regularly scheduled lunch period, provided he/she has the lunch permit in his/her possession at the time.
4. A Junior or Senior who transports a student off campus who does not have off campus lunch privileges will be subject to disciplinary action and/or revocation of the off campus lunch permit and/or parking permit.
5. The student and parent are responsible for where the student goes for lunch and his/her transportation to and from campus. The school assumes no liability for any accident or injury incurred in the exercise of using this lunch privilege.
6. Students exercising off campus lunch privileges are subject to the rules of student conduct as applicable to the regular school day as adopted by the Wake County School Board and Garner Magnet High School.
7. Littering on public or private property will result in the revocation of the lunch pass and/or disciplinary action.
8. All food and drink must be consumed before re-entering the school. You may not deliver any food or drink to any student inside the school. Any attempt to bring food or drink into the school will result in the food and drink being discarded and possible disciplinary action.
9. Students with an off campus lunch pass will be allowed to eat lunch in the student parking lot under the following conditions:
  - You must eat in a vehicle that has an assigned parking spot.
  - The parking lot must be kept clean of trash.
  - No student without an off campus lunch pass is allowed in a vehicle that has an assigned spot.
  - There will be no loitering in the parking lot once you exit the vehicle.
  - No disruptions that require staff to respond.

## **NOTICE:**

The 9<sup>th</sup> Grade Center is no longer a part of GMHS. WCPSS is now using it as a satellite campus for schools currently under construction. With that said, this area is now another campus and is off limits per WCPSS rules and regulations regarding other campuses. At no time should a GMHS student be on their campus. Any student witnessed and/or found on their campus will receive disciplinary actions from GMHS and possibly be cited for trespassing. If you choose to walk to get lunch, you must walk around their campus.
