

Good afternoon, this is Steve Mares, principal of Athens Drive Magnet High School, with a special message for Wednesday, July 29<sup>th</sup>. ### **NEW OR UPDATED ANNOUNCEMENTS:**

Please note that the first four items have actions that need to be taken. For the first three, those actions need to happen by 5:00 p.m. today. Thank you for your attention to these items!

**ACTION NEEDED BY 5:00 P.M. TODAY—COMPLETE TECHNOLOGY NEED SURVEY:** Please remember that we need ALL families to complete the [Wake County Public School System Technology Need Survey](#) by 5:00 p.m. today. ALL families with a student in Kindergarten through 12<sup>th</sup> Grade need to [complete this survey](#) for each student, regardless of school, whether you have applied to the Virtual Academy, whether you have a device or whether you need a device. This is critical information that we need to be sure we have for every student to ensure that when we begin online teaching and learning on Monday, August 17<sup>th</sup>, our students have the tools they need to successfully engage in learning. I would ask that EVERY family complete a survey for EVERY student you have who attends Athens Drive Magnet High School—whether you have technology needs or not, this Survey needs to be completed. Please know that you need to complete this Technology Needs Survey for each student you have in any school at any grade level. However, I want to be sure that you complete a Survey for every student you have at Athens Drive. I completed the Survey for my son and it only took two minutes to complete. Please know that you will need to have your student's ID number to complete the Survey. So, I would ask that you please take two minutes to complete this Survey by 5:00 p.m. today so that we can be sure that we can assist families in ensuring they have the technology necessary to be successful as we begin the year in Online Learning. **ACTION NEEDED BY 5:00 P.M. TODAY—NEW VIRTUAL ACADEMY REGISTRATION PERIOD ENDS TONIGHT:** Based on this new information regarding the changes to the start of the school year, if you want to register your student for our Virtual Academy and you have not yet done so, you must register by 5:00 p.m. tonight. You can register at this [LINK](#). If you want your student to be enrolled in our Virtual Academy, and you have not registered your student yet, this is the last chance to register. If you have already registered your student, we have that information and you do NOT need to complete another application.

**ACTION NEEDED BY 5:00 P.M. TODAY—IF YOU HAVE REGISTERED FOR OUR VIRTUAL ACADEMY BUT NOW WANT TO BE IN OUR BLENDED LEARNING WHEN WE DO RETURN TO SCHOOL:** If you registered for our Virtual Academy and now you believe that our Blended Learning will be the best option for your student/family when we can return to school, you can unenroll from the Virtual Academy. I would ask that a Parent/Guardian email me ([smares@wcpss.net](mailto:smares@wcpss.net)) with your wish to remove your student from the Virtual Academy and I will make that adjustment. I would ask that you please do this prior to today at 5:00 p.m. It is critically important that we get this information as soon as possible so that we can finalize our Master Schedule that we are adjusting. Thank you for letting me know if this is the situation for your student/family.

**ACTION REQUIRED—CLASS OF 2021 VACCINATION REQUIREMENT INFORMATION:** In accordance with North Carolina State Law, all students attending public schools entering the 12<sup>th</sup> Grade are required to receive a booster dose of Meningococcal vaccine. Most medical providers in Wake County are seeing appointments for health assessments and immunizations. At this time, the NC Immunization Program has stated they will not be extending the immunization requirements due to COVID-19. **All required immunizations are due by the first day of school.** If the parent/student has not provided immunization documentation after 30 calendar days from the start of school, the student MUST be excluded from school until documentation is

provided. Please email all immunizations, including the Meningococcal vaccine, to Ms. Sidney, our Registrar, at [psidney@wcpss.net](mailto:psidney@wcpss.net). Thank you for your attention to this vital information.

### **REMINDER ANNOUNCEMENTS FROM PREVIOUS WEEKLY MESSAGES:**

**CHANGE TO THE START OF THE SCHOOL YEAR:** I would imagine that you all have heard, seen, or received information from the Wake County Public School System (WCPSS) regarding the change that was approved by the WCPSS Board of Education yesterday afternoon for the start of the 2020 – 2021 school year. **ALL STUDENTS WILL BEGIN THE YEAR IN ONLINE INSTRUCTION.** Monday, August 17<sup>th</sup> will still be the first day of school for our students, but all students will begin the year in online learning. We have already shifted gears and are beginning to plan for this instructional delivery and please know that we will be communicating details over the course of the next few weeks.

**EXTENDED CURRICULUM STUDENTS RETURNING TO SCHOOL:** We are making plans for our students who receive instruction through our Regional Programs Extended Curriculum classes to return to Athens Drive for daily classroom instruction beginning on Tuesday, September 8<sup>th</sup>. We will all be getting additional information regarding this transition back to our school, but we are excited to plan for these students to return to The Drive each day for instruction on September 8<sup>th</sup>!

**NOW THAT WE KNOW WE ARE OPENING IN ONLINE LEARNING, DO I STILL NEED TO APPLY TO THE VIRTUAL ACADEMY IF I WANT A FULLY REMOTE LEARNING EXPERIENCE FOR MY STUDENT?** I answered this question in my last message to families, but I wanted to revisit it again in this message now that we have a new plan for reopening school. The answer remains the same: Yes. Even though we are now opening the school year in a "Plan B Transition" plan where all students are beginning the school year in online instruction, if you want to ensure that your student only has a remote learning experience, then you need to register for our Virtual Academy. Please know that students who are not in our Virtual Academy could be switched to the Blended Learning model at any time WCPSS deems it safe to have students return to our school. Thus, any student/family who wants to ensure you have a 100% remote learning environment for your student, you need to enroll your student in the Virtual Academy and you will be set, at least for the Semester, but for the

entire year of receiving remote instruction. As I mentioned earlier, if you have already registered, you are good-to-go and you do not need to do anything. If you have not registered, but want to, please be sure to register during the new window from Monday, July 27<sup>th</sup> through Wednesday, July 29<sup>th</sup>. And, if you have registered for our Virtual Academy and have changed your mind, you need to email me ([smares@wcpss.net](mailto:smares@wcpss.net)) and inform me of your decision. Thank you for keeping track of all of this!

**DESCRIPTION OF THE TWO OPTIONS FOR REOPENING OF SCHOOL—VIRTUAL ACADEMY OR BLENDED LEARNING:** I know there are still many questions regarding the difference between what our Virtual Academy program will look like versus our Blended Learning program. And, I know that many of you are still debating exactly which platform for learning will work best for your student and family. I understand your concern and want to provide my thoughts on what both learning platforms will look like. Please understand that we continue to work on our Master Schedule and what the Daily Schedule will look like for students who are attending either option. While we haven't finalized our plans, I did want to help answer many questions that I have been receiving.

**VIRTUAL ACADEMY:**

- Students will be Athens Drive students and will officially be attending Athens Drive.
- Students will be able to participate in co-curricular, athletics, and clubs for Athens Drive while participating in the Virtual Academy.
- Students will still be able to participate in our STEM Academy and our Health Science Career Academy.
- Students are making a commitment of remaining in our Virtual Academy for at least the first Semester, but the recommendation is that the student will remain in the Virtual Academy for the entire year.
- It will be different (e.g., more “live” instruction, grades, rigor, etc.) than the Remote Learning that students experienced in the Spring Semester.
- Our plan is to provide “live” instruction each day, for each class, a student takes.
- Instruction will be provided Monday through Friday.
- We expect learning to be engaging, rigorous, and aligned to the Standards for each course.
- Assessments (e.g., tests, quizzes, research papers, projects, etc.) will be provided to students and grades will be earned.
- Course Grades, course Credits, and course Grade Point Averages will all be calculated the same for both Virtual Academy and Blended Learning.
- There will be a set schedule for classes. Attendance in “live” instruction will be expected, course work outside of the “live” instruction will be required to be completed, and Attendance will be taken.
- Courses will be taught by Athens Drive Teachers. (There may be a time that for a specific course offering we may group our students with students from another high school to be able offer the course to our students. However, I do not foresee this happening often, if at all.)
- Virtual Academy instruction will be a combination of “live” instruction, video instruction, and coursework.
- For those rising Seniors who are eligible, and are interested in Graduating Early (Mid-Year, January 2021), this is still an option.
- It is our plan that students will have access to all Honors and AP course offerings. However, we are still evaluating how we can teach certain classes that need specific tools (e.g.,

Carpentry, etc.) or programs (e.g., Drafting, Programming, etc.) that students may not have access to on their computers or in their homes.

- We are still working on a plan for those courses only taught by one teacher (e.g., Band, Chorus, Theatre, some CTE Course offerings, etc.) to have them available to students in both the Virtual Academy and Blended Learning platforms.

### **BLENDED LEARNING:**

- Students will be Athens Drive students.
- If you do not register for the Virtual Academy, you will be in our Blended Learning program. This is the “default” for all students.
- Students will come to school for in-person learning for a week, and then receive remote learning for the two weeks they are not in school.
- Our plan is to provide “live” instruction each day, for each class. During the in-person learning week, students will receive instruction on campus, in a classroom, and with their teacher. While the student is engaged in remote learning off campus, our plan is to continue “live” instruction for a portion of day. In addition, while in students are engaged in remote learning, students will be expected to complete coursework as well for the course.
- Instruction will be provided Monday through Friday.
- We expect learning to be engaging, rigorous, and aligned to the Standards for each course.
- Assessments (e.g., tests, quizzes, research papers, projects, etc.) will be provided to students and grades will be earned.
- Course Grades, course Credits, and course Grade Point Averages will all be calculated the same for both Virtual Academy and Blended Learning.
- There will be a set schedule for classes. Attendance in “live” instruction will be expected, course work outside of the “live” instruction will be required to be completed, and Attendance will be taken—even when in remote learning.
- Courses will be taught by Athens Drive Teachers.
- We are planning for students to have access each day to their Teacher for “live” instruction and we are working on a plan to provide additional time to our students in remote learning to access other Teachers in a “live” format to get instructional support.
- Students who are in their remote learning from home will be expected to follow a schedule and attend “live” sessions with their teacher.
- For safety reasons, we are planning for the following while students are on campus:
  - Students will only be able to enter at specific entrances each morning with health screening at each entrance (e.g., temperature check, health screening questions, etc.).
  - Students will be required to socially distance throughout the entire day. This is going to be a MAJOR change for students, as we know they will want to gather in groups, talk, hangout, etc. This just cannot happen. Please be sure that you speak to your student to assist them in understanding that returning to school this year will be quite different than returning to school in previous years.
  - Students will eat Lunch in the Cafeteria or Courtyard, but there will be specific seats where students can sit on to ensure social distancing while eating.

- Breakfast and Lunch will be available for students while they are in-person, and while they are remote learning. We are working to provide a plan for a “drive-through” lunch pick-up for students who are not in school but need a meal.

I hope this information helps. However, as with almost everything now, these parameters may change depending on guidance from WCPSS, North Carolina Department of Health and Human Services, North Carolina Department of Public Instruction, and the Governor. Please know that since we haven’t completed the Master Schedule and Daily Schedule for students and staff, it is hard to provide detailed information. We are also still waiting on detailed information/directives regarding instruction in both platforms from Wake County Public School System (WCPSS) to help us be able to finalize our plans. Please know that I will communicate with you more detailed plans as they are created. However, please know that our focus remains on providing a plan for safe teaching and learning for all students to grow and meet their ultimate potential!

**SENIOR INFORMATION:** I wanted to be sure that our Seniors and their families have the information they need to start the year in a positive manner. Here is information for them:

- **SENIOR EVENTS:** I have had several Seniors and their families reach out to me and ask about our Senior events and if they will still happen. If you hear about these messages from others but are not getting them through email and/or text, please contact our Student Services office (919-233-2050 then press 1) to update your contact information in PowerSchool. Please do not forget to check the Athens Website (<https://www.wcpss.net/athensdrivehs>) for continual updates and information regarding our school family.

**STUDENT SCHEDULES FOR THE 2020 – 2021 SCHOOL YEAR:** Please understand that we are continuing to finalize our Master Schedule for the 2020 – 2021 school year. With scheduling students for two options—Virtual Academy and Blended Learning—please understand that student schedules will change. As we get information about the choices that families make with regards to what option they choose, we will be changing our Master Schedule which will impact student schedules. Thus, any schedule that a student currently sees, or will see, in PowerSchool is not final. Please understand that based on these new changes to the reopening of school, we will continue to work on our Master Schedule almost until the first day of school in August. I would ask students and families not to email Counselors or Administrators to discuss schedule change requests. Please understand that a schedule change request process will be established and shared with families in August if there is a need for a student to change his/her schedule.

**JUNIORS AND SENIORS PARKING PASSES:** Please understand that we are waiting on direction from the Wake County Public School System (WCPSS) regarding Parking Passes for the 2020 – 2021 school year. As soon as we have that information, we will be disseminating applications, information, and directions for student parking. Thank you, again, for your patience with regards to this school process.

**OFF-CAMPUS LUNCH PASS:** At this time, we have not made a final decision if we will be allowing students to leave campus for lunch. Thus, we are not offering Off-Campus Lunch Passes for Juniors and Seniors. As soon as we make final decisions about this privilege, I will communicate information to our Juniors, Seniors, and school families.

**ATHLETIC PARTICIPATION INFORMATION:** Right now, there is a lot up in the air regarding athletic participation as we await decisions from Governor Cooper and the North Carolina High School Athletic Association (NCHSAA) on if we will be able to restart athletics for the 2020 – 2021 school year. **NORTH CAROLINA HIGH SCHOOL ATHLETIC ASSOCIATION (NCHSAA) CHANGES TO PHYSICAL POLICY:** The NCHSAA has made quite a few changes for the coming year in response to the COVID-19 pandemic with regards to Physical forms. The updated policy regarding Physicals is outlined below

in the table. We have been informed that all student athletes who had a valid Pre-Participation Examination (PPE) form dated anytime from March 1<sup>st</sup>, 2019 through May 1<sup>st</sup>, 2020 (used for the 2019 – 2020 school year) will be granted an emergency one-year extension through the end of the 2020 – 2021 school year. I hope this table helps you understand the new interpretations for participating in Athletics for the 2020 – 2021 Athletic Seasons:

Date of Current Physical	Requirement for 2020 – 2021 School Year
Prior to 03/01/2019	Need valid, up-to-date physical prior to participating.
On or after 03/01/2019 through 05/01/2020	Granted a temporary extension to participate through the end of the 2020 – 2021 academic school year.
On or after 05/02/20	Will participate based on the current policy of being “valid for 395 days.”

If allowed this summer, a student athlete can participate in 2020 Summer Workouts with a physical dated on-or-after March 1<sup>st</sup>, 2019. Please also remember that a rising Ninth Grade student athlete is also subject to all the above. **Please understand that all student athletes will still need to submit new registration paperwork prior to participating in any Workouts/Practices even if their Physical has not expired.** Thank you for your understanding of the changing aspects of requirements for our student athletes.

**DRIVERS EDUCATION UPDATE:** Jordan Driving School is not accepting any new registration forms at this time. Once the class schedule has been determined for the school year, it along with the 2020 - 2021 Driver Education Registration form will be posted at [www.jordandriving.com](http://www.jordandriving.com). Continue to monitor the Jordan Driving website for updates on the upcoming school year. Please see the [Drivers Education Update](#) from WCPSS for additional information.

**PROCESS FOR OBTAINING A DRIVER'S ELIGIBILITY CERTIFICATE:** To meet the needs of our students and families, we will be implementing the following process to allow students to receive a Driver's Eligibility Certificate (DEC) while our school building is closed due to COVID-19. Please remember that DEC's are only valid for 30 days; therefore, students are only eligible to receive a DEC during this time if they have a **confirmed appointment with the NCDMV within 30 days of the date of the request.** You will start by sending an email request to Ms. Teresa Brown ([tbrown3@wcpss.net](mailto:tbrown3@wcpss.net)), Dean of Students, and include the email from NCDMV confirming the date/time of the appointment. You will receive an email confirming the date/time you can come to the high school to receive the DEC. Once your appointment is confirmed with us, the following steps will be taken:

- Step 1: Scan or take a photo of the following:
  - Student's birth certificate or passport
  - Completed Driver's Education Certificate (if it has not been emailed ahead of time)
  - Proof of address if the current address is different than the one listed on the Driver's Education Certificate or the address listed in PowerSchool. Address must be verified for the NC Real ID.
  - Email this information to Ms. Brown, our designated contact at the school. This will limit the amount of paper that has to be exchanged by staff and students. If you are unable to scan or take a photo of the document, then you will need to bring all these documents with you to the appointment.
- Step 2: Bring the following documents to the appointment:
  - Student's birth certificate or passport
  - Completed Driver's Education Certificate (if it has not been emailed ahead of time)
  - Proof of address if the current address is different than the one listed on the Driver's Education Certificate or the address listed in PowerSchool. Address must be verified for the NC Real ID.
- Step 3: Receiving the DEC:
  - Once you arrive for your appointment, a staff member will meet you at the front door of the school (entrance by the flagpole) to receive the DEC. It is important that we limit the amount of direct contact and maintain at least 6 feet of social distance. For this reason, please limit the number of family members (preferably just the student and a parent or guardian) who attend the appointment. Please arrive at the school promptly for your scheduled appointment to ensure that we can follow the social distancing guidelines that have been established.
  - Staff will check the student's grades for adequate progress. The student must have passed 70% of the courses taken in the prior semester to receive a DEC.
  - Once grades have been verified and all other documents are in place, the DEC can be issued to the student.

Thank you for your understanding and support of this process to continue to provide DEC's to our students.

**SUMMER HOURS FOR SCHOOL OPENING:** Please know that we will have a few staff on campus each day from 8:00 a.m. until 2:00 p.m. Please understand that due to the COVID-19 pandemic, the building is closed for visitors. However, for families who have important business, the building is open to take care of those student/family needs. Please know that to best protect our staff and visitors, anybody on campus must always wear a mask/face covering. Thank you for your understanding.
