All juniors and seniors who wish to receive a parking space should complete and submit the application for on-

Application

submit the application for oncampus vehicle operation and parking to the main office during a designated time (see third bullet below).

- Completed applications must also include copies of the student's North Carolina Driver License (front and back) and copies of registration for any vehicles being registered (no more than 2 vehicles allowed per space). The front office staff will <u>NOT</u> make copies of docments for students.
- Applications can be submitted to the front office during lunch beginning May 29, 2018 until June 11, 2018. After June 11, applications can be submitted to the front office between 8:00 am until 10:00 am on Tuesdays and Thursdays. Deadline for applications is Aug. 2, 2018.

Payment

Online sales will open at midnight on July 1, 2018. Beginning on July 10, 2018, in-person sales (with exact cash or check) will be collected on Tuesdays and Thursdays from 8:00 am until 10:00 am in the front office.

- Seniors wishing to get a parking space in the senior priority window, should submit payment by August 2nd at 3:00 pm. The first 450 seniors who submit a completed application and payment will be guaranteed spots.
- Juniors who apply for a parking space should wait to make payment until they have received notification that they have been chosen for a spot. We anticipate contacting students about parking spaces that remain after the senior priority window on/around August 11 (please, do not call the office).

Parking Pass

- Once all of the previous steps have been completed, students will be able to retrieve their parking pass.
- Seniors can pick up their passes on August 8 between 8:00 am and 10:00 am or on August 9 between 1:00 pm and 3:00 pm.
- August 21 will be the makeup day for pass pickup. This is also the day on which parking spaces that were left over from the senior priority window will be distributed to juniors and/or seniors who did not get a space during the initial window.

- Applications can be submitted to the front office during lunch beginning May 29, 2018 until June 11, 2018. After June 11, applications can be submitted to the front office between 8:00 am until 10:00 am on Tuesdays and Thursdays.

Payment

 Lunch passes are available for \$5. Passes can be purchased online using the Online School Payment site beginning on July 1 at midnight or in person. Inperson sales will take place on August 8th (8:00 am -10:00 am), 9th (1:00 pm -3:00 pm), and 21st (9:00 am -11:00 am).

Lunch Pass

 Once all of the previous steps have been completed, students will be able to retrieve their off-campus lunch pass on one of the following dates at the specified times:

> August 8 (8 am-10 am) August 9 (1 pm-3 pm) August 21 (9 am-11 am)

Once students receive their initial off-campus lunch pass,
 REPLACEMENT PASSES WILL NOT BE ISSUED THIS YEAR, except under extremely extenuating circumastances that will require administrative approval and a separate application process that will be closely scrutinized.
