

BRING YOUR OWN DEVICE (BYOD) EXPLANATION AND TERMS OF AGREEMENT

This form has been updated as of October 8, 2020.

The purpose of this document is to inform parents, guardians, and students of the rules governing the use of personally owned devices while on or near school property (including school-based transportation), at school sponsored activities, and while remotely accessing the district's technology resources.

WCPSS Vision

Student devices will be used to support learning, enhance instruction, and provide the best possible outcome for student achievement. Additionally, WCPSS will assist students in practicing sound digital citizenship.

Overview

Personal devices are defined as privately owned and portable electronics capable of wireless Internet access, capturing image/video/audio, and/or transmitting information.

Students who do not bring their own devices to school will be provided access to school-owned technology.

Security and Damages

WCPSS employees are not liable for any device that is stolen or damaged.

4	Administrators reserve the right to examine any device as needed.		
5	Printing from personal devices is prohibited at school.		
6	Images/audio/video of any person on campus or attending a school-sponsored event may not be captured, transmitted, and/or posted in print or digital form unless directed by a WCPSS employee.		
7	Sharing of personal devices is prohibited.		
8	Devices must be connected to a WCPSS network.		
9	District policies and procedures apply to personal devices at school-sponsored events and on school-based transportation.		
10	Principals may establish additional rules related to the use of personal devices at his or her school.
