# Final COVID-19 Relief Response Bill - Education Highlights

## Major Funding Items:

- School Nutrition (\$75 million)
- Devices/connectivity (\$47)
- Instructional Support Allotment to DPI (\$10) for contracted services for school health support personnel
- DPI Grants for Extended Learning and Integrated Student Supports Competitive Grant Program (\$5 for at-risk students)
- Statewide Shared Cybersecurity Infrastructure (\$4.5 to DPI)
- Expand Learning Management Platform (\$1.5)
- Non-digital Remote Instruction Resources for students with limited connectivity (\$3)

# COVID-19 Relief Bill - Education Highlights cont.

## Major Funding items (cont.):

- Summer Learning Program (\$70)
  - LEA must submit Learning Plan to DPI by June 22, 2020 and;
  - Funds must be used by Dec. 30, 2020 for students who have been negatively impacted by the impacts of COVID-19
    - Reading interventions (K-3) based on administered assessments
    - Reading interventions (4-5) based on teacher identification
    - Math interventions (K-4)
    - These days **not** a part of the scheduled instructional days
- DPI Grants (\$15) to support extraordinary costs associated with Extended School Year needs of exceptional children who qualify for services

# COVID-19 Relief Bill - Education Highlights cont.

## Major Bill Provisions:

- **Accountability**
  - Waive all EOC's and EOG's
  - ACT administration in the fall for juniors (now seniors) who missed
  - K-3 diagnostics/formative requirements after March 13 waived
  - WorkKeys test waived for CTE concentrators
- **Annual School Report Cards**
  - School Performance Grades not displayed for 2020-21 based on 2019-20 data
  - LEA's not required to produce School Building Reports based on 2019-20 data

## Major Bill Provisions (cont.):

- **Designations of Low-Performing/Continuously Low-Performing**
  - No schools identified for the 2020-21 school year
  - Schools previously identified will continue in same designation
  - Schools previously identified will continue to carry out SIP
- **Innovative School District**
  - No new schools identified as “qualifying” schools based on 2019-20 data
  - Schools identified in 2019-20 (based on 2018-19 data remain)

# COVID-19 Relief Bill - Education Highlights cont.

## Major Bill Provisions (cont.):

- Third Grade Retention, Reading Camps, Fourth Grade Reading Assessment, report to SBE
- Advanced Math Course Placement
- CPR Graduation Requirements waived for 2019-20 (current 12th grade students)
- School Calendar for 2019-20 - if districts have implemented remote instruction during the closure, they are deemed to have satisfied the minimum days/hours required for 2019-20

## Major Bill Provisions (cont.)

- School Calendar 2020-21
  - Each LEA must submit a Remote Learning Plan by July 20, 2020
  - Every calendar must include 5 days of remote learning, beyond the days already included in the Board approved calendars that meet all legislative requirements
  - With the exception of YR/Modified/ECHS/Approved Restart, all schools must have an opening date of August 17, 2020 and a closing date of June 11, 2021 and Remote days can not be scheduled prior to August 24, 2020

- School Improvement Plans
- Principal Recruitment Supplement
- Teacher Effectiveness Reporting
- Teacher Evaluations and Observations\*\*
- Expansion of Licensure requirements (Teachers/School Personnel)
