## RULES FOR CARY HIGH SCHOOL PARKING LOT

\*Read and initial each statement as your agreement to the rules for the CHS Parking Lot Parking spaces will be sold to Cary High School juniors and seniors only. Student must park is in his/her assigned space on campus between 6:45 a.m. and 2:30 p.m. Student must pull forward into your spot, **NO pull thrus**. Parking **ANYWHERE** else will result in disciplinary action, towing fines levied and/or suspension of parking privilege. All fees and fines, and senior dues if applicable, must be paid in the main office prior to purchase of parking pass. Parking hang tags must be always displayed. If lost, replacement tags cost \$10. No loitering in parking lots. All students must leave the parking lots immediately upon arrival or dismissal from school. Students must not return to the parking lot without permission from an administrator. All traffic signs and roadway markings must be obeyed at all times. Reckless driving, speeding, burn outs and activities that endanger self and/or others will not be tolerated. Must follow the directions/request of the security officer and administration to keep parking privileges. Cary High School and Wake County Public Schools are not responsible for damages to vehicles, and for lost or stolen articles left in vehicles. Vehicles are subject to search during routine checks during the school year, and if there are reasonable grounds to believe that drugs, weapons, alcohol, stolen property, or other contraband might be present. Students are not to litter the parking lot. Parking passes are not to be sold or exchanged with other students. Parking pass will be revoked if this is discovered.
